ENTRY FEES:

Solo categories: \$15/event
 Team Categories: \$15/rider/event
 Juniors: FREE

PRIZE ELIGIBILITY: Solo categories must participate in two of the three events, placing determined by two best combined times; Team categories require one event, placing by best time in the series, time determined from the second rider to finish. At least two pairs in each team/tandem category before any pay-out is earned; Merckx categories limited to conventional road bikes no aero bars, aerodynamic wheels, or aero helmets.

REGISTRATION AND START TIME: Pre-registration at <http://www.bikereg.com> until 5:00 PM the day before each event. A \$5 late fee charged for same day registration. Registration is **STRICTLY** open only from **7:15-8:00 AM**. Registration order determines start time. The earlier you register (on-line first, then in person), the earlier your start time. **First rider off at 8:30 AM** One-day licenses will be available for those without an annual license, \$10/event. One day licensees may ONLY race in Men's Cat 5 or Women's Cat 4 (USCF Rule 1C11).

DIRECTIONS: Exit North from I-40 on Council Road (Exit 142). Go North on Council to N.W. 10th Street. Turn left (West) on 10th street and go to first stop light (County Line Road). There is a 7-11 on the N.E. corner. Turn Right (North) on County Line Road. County Line Road dead ends at the start/finish area.

RULES: All USAC 2010 rules are in effect including: the wearing of a helmet and a jersey with sleeves; reporting to the starting line at least 3 minutes prior to a rider's designated start; riders must stay on the right side of the road centerline; maintain a drafting spread of 80 feet behind a rider or else moving 7 feet off to the side; and all other Section 3E requirements. Race to be held rain or shine, except for lightning or ice. Only USAC regulation bicycles will be permitted. The promoter reserves the right to adjust the start times, mileage, or cancel/combine categories and prize lists as necessary. **Juniors (10-18)** will need to report by 7:30 AM on race day to have their gearing inspected for USAC compliance (Rule 1M6).
